## KATA-KATA PENDAHULUAN

Saudara Kaum Pekerja Sekelian,

Saya ingin menyampaikan dengan ringkas perihal Ahli-Ahli Jawatankuasa Tertinggi yang ada sekarang ini dan juga kejayaan dan kegagalan perjuangan kita di-masa lampau, di-masa 1973/1974.

Menimbangkan di-antara kejayaan dan kegagalan, saya berasa bangga untuk menyatakan bahawa kita ada membuat kejayaan yang memuskan hati dan juga sedikit kegagalan di-dalam perjuangan kita.

Kita patutlah mempunyai keberanian dan insperasi untuk menghadapi segala gertak-gertak majikan seperti:- Pergantongan kerja, pemuangan kerja, dan amaran yang di-berikan oleh majikan. Tetapi ini adalah satu cara hidup kita untuk menghadapi penghidupan. Gertakan-gertakan seperti ini pernah di-terima selalu oleh ahli-ahli kita di-semua Kilang.

Tidaklah senang bagi kita menyatakan yang semua masalah-masalah ini dapat di-selesaikan antara Kesatuan dengan Majikan. Kita akan bernasib baik jika kebanyakan masalah dapat di-selesaikan tanpa di bicarakan di peringkat tinggi, seperti di peringkat Mahkamah Perusahaan dan Pegawai Pegawai Perhubungan Perusahaan Kementerian Buruh dan Tenaga Rakyat. Dengan cara persafahaman antara pihak majikan, kita dapat menyelesaikan masalah ini di-meja perundingan.

Apabila Jawatankuasa Tertinggi mengambil alih pentadbiran pada bulan Mei, 1974, ahli ahli yang berhak ialah sebanyak 2,000 orang. Pada masa saya menyiapakan laporan ini, bilangan ahli-ahli Kesatuan kita ialah lebih kurang 4,000 orang, saya sungguh kagum. Apabila ahli-ahli meningkat naik sudahlah menjadi kebiasaan banyaknya masalah masalah yang di hadapi sekarang.

Dukacita kami nyatakan di sini, iaitu kami Ahli-Ahli Jawatankuasa Tertinggi bukan mendapat pertolongan dan kerjasama dari ahli-ahli kita sendiri di dalam apa apa hal pun. Umpamanya, apabila kita, menghadapi masalah dan di bicarakan di Pejabat Pegawai Perhubungan Raya, Kementerian Buruh dan Tenaga Rakyat, kita selalu terperanjat kerana ahli-ahli kita sendiri ragu ragu untuk berpihak kepada kesatuan. Sebaliknya, mereka menjadi saksi di pihak majikan. Anda sekelian akan hairan mengapa ahli-ahli kita sendiri berpihak kepada majikan. Jawapannya senang sahaja, mungkin majikan berjanji hendak memberi kenaikan pangkat kepada mereka, selagi mereka ini berganding bahu dengan majikan. Inilah yang menyebabkan salah faham di antara pekerja-pekerja sendiri.

Saudara ku sekelian, sekalilagi saya menyuarakan kepada anda dan selalu sedar dan bertanyakan apakah maknanya, "KESATUAN". Ertinya senang sahaja di perkatakan bersatupadu. Dan inilah maknanya yang sebenar. Jika kita selalu berbalah sesama sendiri, saya dengan positifnya menyatakan yang kita akan selalu kalah untuk menentang majikan majikan yang kapitalis.

Dengan keseluruhannya saya menyatakan di sini, sokongan penuh kepada Kesatuan hendaklah datangnya daripada hati yang ikhlas dari tiap tiap pekerja. Dan mereka hendaklah sedar bahawa Kesatuan adalah tempat perlindungan mereka. Jika ingatan ini selalu berada di dalam kepala mereka, sudah tentulah kita akan dapat menentangi segala kejahatan musuh kita yang ketat iaitu majikan. Janganlah sekali sekali kita menyerahkan diri kita kepada majikan yang tidak mempunyai fikiran yang waras ini. Oleh itu hendaklah kita sedar, bahawa bersatu padu kita tegoh dan berceraai kita roboh. Sebab inilah menjadi satu masalah besar bagi kami Ahli Jawatankuasa Tertinggi untuk menjaga nama baik kesatuan, "Kesatuan Pekerja Pekerja Perusahaan Alat Alat Pengangkutan dan Sekutu".

Sudah tentu anda sekalian tahu bahawa Jawatankuasa Tertinggi Kesatuan kita adalah satu badan yang memegang kuasa penuh degala arahan arahnya. Tetapi dukacita di nyatakan kebanyakan ahli ahlinya selalu bergaduh sesama sendiri. Jika kejadian ini selalu berlaku bagaimanakah kita yang memegang jawatan di majlis tertinggi ini dapat menunjukkan tauladan yang baik kepada ahli ahli kita yang lain. Boleh jadi hendak mengujjudkan persafahaman di antara ahli ahli akan menjadi masalah. Sudah tentu, mengapa tidak? Oleh itu, Wahai saudara ku sekalian, ingin saya menyampaikan kepada saudara nasihat yang berguna - Pilehlah pemimpin yang saudara percayai dan yakinlah yang ianya akan mengambil berat di atas nasib pekerja, dan isinya akan berada di dalam pentadbiran pejabat buat masa yang akan datang. Bukan sahaja calun yang betul menyelesaikan masalah yang di hadapi oleh pekerja-pekerja nya menjadi saorang penyuaranya pekerja-pekerja tidaklah cukup. Ia hendaklah liberal di dalam apa apa jua yang ianya menghadapi. Pilehlah calun saudara dengan berhati hati yang akan memberi faedah kepada saudara jua.

Sebelum saya berundur diri, saya menyerukepada saudara sekalian, marilah kita bersatupadu di bawah naungan bendera kesatuan yang kita semua cintai. Janganlah ada sikap berlainan hendaknya di antara orang yang di atas dengan ahli ahli biasa. Biasalah selalu ada keamanan dan cinta kasih sesama kita. Marilah kita bersama mara kehadiran untuk faedah kita semua di bawah naungan bendera, "Kesatuan Pekerja Pekerja Perusahaan Alat Alat Pengangkutan dan Sekutu. Di manakah adanya perjanjian di antara sitamak dengan yang sederhana dan di manakah adanya keamanan di antara sikaya dengan simiskin.

NOTA

Sesungguhnya, baik juga saudara sekalian mengambil tahu mengapa saudara Mun Chee Wah telah di lucutkan jawatannya dari menjadi Bendahari - mungkin sebilangan daripada saudara merasa bingung dan tidak faham sedalamnya yang menyebabkan beliau di lucutkan dan di tendang dari jawatan kuasa Tertinggi. Saya mahu memberi sebab sebab mengapa pehak jawatankuasa Tertinggi mengambil tindakan yang begitu keras sekali terhadap beliau. Di masa beliau memegang jawatan Bendahari beliau terlalu tamak dan cuba mengambil tahu di dalam hal Ahli Jawatankuasa Tertinggi yang lain, terutama sekali mengenai pentadbiran kesatuan. Beliau suka monopoli kegiatan kesatuan dengan tidak mendapat apa apa keheharaan daripada Jawatankuasa Tertinggi.

Selepas perlucutan jawatan Bendahari Saudara Mun Chee Wah, Jawatankuasa Tertinggi telah mencadangkan saudara Wong Teck Min di lantik menjadi Pemangku Bendahari. Perlantikan Saudara Wong Teck Min, telah di persetujui oleh Jawatankuasa Tertinggi dan juga dengan Kuatkuasa Perlembagaan Kesatuan kita - Fasal 12 Clause 8. Perlantikan ini kuatkuasa pada 27hb. Mei, 1974.

Sekarang marilah kita renung kembali kepada perletakan jawatan dari Ahli Ahli Jawatankuasa Tertinggi yang lain.

Saudar Samsuddin Samian, bekas Timbalan Presiden telah meletakkan jawatan nya dari Syarikat General Motors (M) Sdn. Bhd., Johore Bahru, pada 16hb. Disember, 1973.

Dan Saudara Mohammed Hamid telah di jemput oleh Jawatkuasa Tertinggi untuk memenuhi kekosongan ini. Beliau telah menerima permintaan ini dengan penuh ikhlas . Yang sebenarnya di masa pilehan yang di adakan pada yang lampau, beliau ada bertanding untuk tempat Timbalan Presiden. Beliau telah mendapat bilangan undi yang memuskan yang mana membolehkan beliau memegang jawatan Timbalan Presiden. Beliau memegang Jawatan ini pada 23hb. Mach, 1974.

Saudara A. Arumugam bekas Setiausaha Agung terpaksa meninggalkan jawatnnya keran beliau telah di naikkan pangkat sabagai "Foreman" di tempat beliau bekerja, Syarikat Associated Motor Industries. Beliau adalah salah seorang daripada Jawatankuasa Tertinggi yang dapat menyempurkan perjanjian sekumpul "Collective Agreement" dengan Persatuan Pemasang Pemasang Kereta Kereta Motor dan Kesatuan Kita. Dan di tandatangani bersama pada 20hb. Disember, 1972. Kerana kenaikan pangkat "Foreman" beliau terpaksa meninggalkan jawatannya sebagai Setiausaha Agung. Dan juga di sebabkan oleh perlombongan Kesatuan Kita tidak mengizinkan sa seorang ahlinya memegang dua jawatan. Oleh kerana peletakan resmi beliau dari jawatan Setiausaha Agung, maka dengan secara otomatik Saudara Charles Mah Yong Hwee di lantik menjadi Pemandu Setiausaha Agung dengan kuatkuasa di turunkan yang sama.

Tetapi dukacita di nyatakan bahawa kedudukan saudar Charles Mah Yong Hwee sebagai Pemandu Setiausaha Agung adalah di dalam keadaan Waswas. Sebagai sa orang pekerja Syarikat Hargill Engineering Sdn. Bhd., beliau juga termasuk di dalam senarai nama nama pekerja yang telah di buang kerja oleh majikan tersebut. Pekerja ini telah di kemukakan ke mahkamah Perusahaan untuk mendapat penyelesaian. Hanya menunggu keputusan dari Mahkamah ini yang memakan masa dua bulan. Dan bagi kami untuk menimbangkan sama ada beliau ini sah atau pun tidak bagi memegang jawatan Pemandu Setiausaha Agung. Sungguhlah sedih di atas perkara ini.

Jika merenong kembali di atas kedudukan beliau, kita benar memperkatakan yang beliau ini tidak sah lagi memegang apa apa jawatan mustahak di dalam Kesatuan Pekerja Pekerja Perusahaan Alat Alat Pengangkutan dan Sekutu. Pehak kesatuan pentadbiran Sekerja Malaysia telah membuktikan beliau tidak boleh memegang apa apa jawatan yang tinggi dalam kesatuan.

Oleh kerana tiada jalan yang lain lagi, Presiden sendiri sekarang ini mempunyai kuasa untuk memilih daripada Ahli Ahli Jawatankuasa Yang lain bagi memegang pentadbiran kesatuan mengikut Perlembagaan Kesatuan Kita Fasal 12 Bahagian 8. Dengan itu Saudara Presiden telah mengangkat saudara Micheal samy yang terlama sekali di antara Ahli Ahli Jawatankuasa Tertinggi untuk memegang pentadbiran kesatuan bagi pehak Pemandu Setiausaha Agung. Perlantikan beliau berkuatkuasa pada 6hb. Ogos, 1974.

Saudara Osman bin Mohammed Nor, bekas Ahli Jawatankuasa Tertinggi telah meletakkan jawatan dari Ahli Ahli Jawatankuasa Tertinggi dan juga Kesatuan, di sebabkan beliau juga telah di naikkan pangkat "Foreman" seperti Saudara A. Arumugam.

Perletakan Jawatan beliau dari Jawatankuasa Tertinggi berkuatkuasa pada 31hb. Mei, 1974.

Saudara Jamaluddin juga meletakkan jawatan dari Jawatankuasa Tertinggi dan kesatuan pada 25hb. November, 1973. Beliau juga meletakkan jawatan nya di Syarikat Asia Automotive (M) Sdn. Bhd., Beliau berlepas ke seberang laut dalam pertengahan bulan Desember, 1973. Tempat beliau di ganti oleh saudara Micheal Foong Chin Bee dengan kuatkuasa 26hb. November, 1973.

Walaupun telah banyak perletakan jawatan seperti mana saudara sekalian boleh lihat, namun begitu Jawatankuasa Tertinggi cukup suara untuk meluluskan satu perkara di masa mesyuarat. Dengan itu terselamatlah Jawatankuasa Tertinggi daripada tidak bergerak dengan sempurna. Semasa saya menyiapkan laporan ini, saya merasa bangga untuk menyatakan bahawa telah berjaya mengadakan 11 kali mesyuarat Jawatankuasa Tertinggi dengan di ikuti pula 10 kali mesyuarat tergempar EXKO. Juga di saat ini, pehak Jawatankuasa Tertinggi telah berjaya mengadakan mesyuarat bersama di antara Jawatankuasa Tertinggi dengan Jawatankuasa Kerja. Patutlah kita banggakan kejayaan ini.

#### MESYUARAT AGUNG TERGEMPAR

Mesyuarat ini telah di adakan di dalam keadaan mesra dan bertempat di Dewan Kesatuan Pekerja Pekerja Pengangkutan, Jalan Barat, Petaling Jaya, Selangor, Pada 2hb. Disember, 1973. Agenda utama ialah mengesahkan laporan kira kira tahun 1972/1973. Sunguh sungguh dukacita lalu juru odit luar telah lambat menghantar kembali laporan kira kira ini setelah di odit oleh mereka. Telah di cadangkan pindaan bagi undang undang hendaklah di buat dengan segera.

Bukan sahaja sebab sebab yang di berikan seperti di atas, juga kerana bilangan kedatangan ahli ahli di masa itu sangatlah tidak memuaskan Mengikut Perlembagaan Kesatuan kita sekurang kurangnya 50% daripada jumlah kedatangan ahli ahli adalah di wajibkan kalau kita betul betul handak membuat pindaan terhadap undang undang untuk menjagakan kemahuan ini, maka saya merayu kepada saudara sekalian datanglah beramai ramai ke mesyuarat agung tahunan yang akan di adakan nanti, supaya dapat kita semua mengambil tindakan membuat pindaan terhadap Perlembagaan kita.

Kembali kita berkenaan mesyuarat di atas tadi, Laporan kira kira tahun 1972/1973 di luluskan. Dan juga perlantikan resmi dua orang juru kira undi sebagai ganti juru kira undi lama yang telah meletakkan jawatan kesemua dari Syarikat Cycle and Carriage (M) Sdn. Bhd., Petaling Jaya.

PERTIKAIAN

Saya fikir bahawa tahun 1974 adalah satu tahun yang tidak begitu baik kepada Kesatuan kita.

Pada hari Jumaat 18hb. Februari, 1974, seorang daripada kaki tangan Pejabat kita Saudara Omar bin Nordin telah mendapat kemalangan jalan raya semasa menjalankan tugasnya. Beliau telah meninggal dunia.

Sepeninggalan beliau, keluarga beliau menghadapi masa hadapan yang gelap bagaimana hendak memberi penangungan kepada lima orang anak. Kami mengetahui kesukaran yang di hadapi oleh keluarga beliau. Dengan serta merta kami membuat kutipan kilat dari ahli ahli kita yang telah begitu bermurah hati mengeluarkan derma. Ini di buat dari semua kilang.

Wang kutipan derma ini telah di serahkan kepada bahu beliau. Penyerahan pertama telah di buat pada 13hb. Julai, 1974. Sebanyak \$300.00 dan yang kedua pada 23hb. Julai bertempat di Pejabat Peguam Kesatuan. Wang Penyerahan yang kedua ialah sebanyak \$1,713.25. Penyerahan ini telah di saksikan oleh saudara Basri bin Hj. Ahmad, Wong Teck Min dan Joseph Ambrose, Pegawai Perhubungan Perusahaan Kesatuan kita.

Jawatankuasa Tertinggi menyampaikan terima kasih kepada semua ahli ahli dari semua kilang, kerana memberi bantuan yang cermelang ini.

Fasal kemalangan ini, pehak Jawatankuasa Tertinggi telah membuat beberapa persediaan untuk mendapatkan keadilan dengan saksama.

SYARIKAT HARGILL ENGINEERING (M) SDN. BHD

Satu kejadian yang mendukacitakan telah berlaku di Syarikat ini dimana semua ahli ahli kita telah di buang kerja pada 31hb. Mei, 1974. Pemuangan kerja beramai ramai ini adalah di sebabkan oleh ahli ahli pergi mendapatkan rawatan beramai-ramai. Kejadian ini telah dibawa ke perhatian Eksko. Dengan serta merta mereka campurtangan, cuba menyelesaikan perkara ini.

Apabila ahli-ahli ini mula berpiket di luar kawasan kilang, maka Ibu Pejabat Kesatuan terpaksa menolong mereka ini dengan bantuan keawangan. Pihak Exko, telah mencadangkan untuk menghulurkan pertolongan keawangan untuk membolehkan mereka membeli barang-barang. Kegunaan sehari-hari.

Kami meminta Kementerian yang berkenaan campurtangan bagi menyelesaikan masaalah ini. Di masa mesyuarat bersama dengan Majikan tidak ada apa-apa penyelesaian.

Kemudian, satu lagi mesyuarat bersama diadakan oleh Kemeterian Buruh dan Tenaga Rakyat. Kali ini berjaya, 178 orang pekerja-pekerja dari 202 telah dipersetujui oleh Majikan untuk bekerja semula. Tetapi, 24 orang lagi ditinggalkan dahulu. Perkara ini telah dirujuk kepada Mahkamah Perusahaan. Apakah akan terjadi kepada nasib mereka dimasa depan.

Oleh kerana tiada penyelesaian terhadap 24 orang pekerja, pihak Exko telah bercadang hendak mengambil tindakan peringkat nasional untuk memberi sokongan kepada pekerja-pekerja Hargill Engineering. Sebelun, kami torbuat demikian terlebih dahulu kami telah ribitkan olah pihak Kementerian dan pihak Pendaftaran Kesatuan Sekerja Malaysia supaya jangan mengambil tindakan itu, jikalau tidak Kesatuan kita akan disingkirkan dari pendaftaran tanpa memberi apa-apa amaran lagi.

Dimasa saya menyiapkan laporan ini, perkara ini telah pun diserahkan kepada Mahkamah Perusahaan. Maka hanyalah menunggu masa apakah keputusan setelah pendengaran dibuat pada 24hb September, 25hb September dan 26hb September, 1974. Mahkamah sahaja akan menentukannya.

Tindakan seperti ini yang diambil secara bersendirian, oleh ahli-ahli kita di Hargill Engineering adalah menjadi satu tauladan kepada ahli-ahli kita yang lain jangan mengambil tindakan secara bersendirian. Oleh itu, saya menyeru kepada saudara sekalian fikirilah dua kali sebelum mengambil tindakan. Jika saudara sekalian hendak mengambil apa-apa tindakan, lebih baik saudara terlebih dahulu mendapat nasihat dari jawatankuasa tertinggi. Janganlah melemarkan diri dalam arus yang kuat. Sebagaimana saudara sekalian telah mengetahui, bahawa undang-undang Buruh di negara lebih mementingkan hak-hak Majikan dan bukan Kesatuan. Oleh itu saudara sekalian sepatutnya memahami akan kedudukan kesatuan yang sebenarnya.

CHAMPION MOTORS INDUSTRIES (M) SDN BHD

Pekerja-pekerja di Syarikat Champion Motors telah mengambil tindakan perusahaan kerana memperjuangkan Elaun Sara Hidup dan juga memendekkan masa kerja mereka. Pihak Majikan telah bersetuju akan permintaan mereka. Dengan kejayaan mereka, perjanjian ini telah ditandatangani bersama diantara Kesatuan dengan Majikan. Bagi pihak Kesatuan ialah seperti berikut :-

ELAUN SARA HIDUP

Pekerja-pekerja di Malaysia sungguh merasa sengsara disebabkan kenaikan harga barang-barang kegunaan sehari-hari. Di saat ini, pihak Majikan telah dapat keuntungan yang banyak dan kemudian dihantar keluar negeri.

Memandangkan kepada keadaan hebat ini, maka pihak Kerajaan telah mencadangkan untuk mengeluarkan satu undang-undang meminta semua majikan memberi elaun sara hidup khas kepada pekerja-pekerja mereka.

Sebelum undang-undang ini dilaksanakan kami telah mengadakan perbincangan dengan kesatuan Pemasang Kereta-Kereta Motor, Malaysia dan telah bersetuju membuat pembayaran pada mulai bulan Oktober, 1973. Tetapi, ini ditolak oleh majikan. Kemudian, kami berjumpa lagi di Kementerian Buruh dan Tenaga Rakyat. Ini berjalan masa buat beberapa kali.

Kami telah mencadangkan kepada majikan, iaitu pembayaran ini dibuat seperti dibawah ini :-

1. Pekerja-pekerja yang menerima gaji \$300/= kebawah - elaun dibayar \$30/=
2. Pekerja-pekerja yang menerima gaji \$301/= keatas - elaun dibayar \$25/=

Tiap-tiap pekerja dibayar 40% daripada gaji bulanan mereka, sepertimana dicadangkan oleh Kesatuan, tetapi ini juga tidak dipersetujui oleh Majikan.

Oleh itu, sekali lagi kami bertemu dengan majikan beberapa kali, di Kementerian Buruh dan Tenaga Rakyat. Apabila kegagalan ini didapati oleh pekerja-pekerja kita disemua kilang, dengan serta merta mengambil tindakan bekerja perlahan-lahan dengan cara bersendirian. Tindakan ini adalah bertindakan bagi perjuangan mereka mengenai bayaran KOLA. Mereka mengambil tindakan tanpa mendapat apa-apa arahan dari jawatankuasa tertinggi dengan secara otomatik pengeluaran dari semua kilang telah merusut.

Setelah menyedari hal ini, majikan-majikan telah melapurkan kepada Yang Berhormat Menteri Buruh dan Tenaga Rakyat, Tan Sri Manickavasagam. Beliau telah menjemput kami untuk bermesyuarat dengan sefta-merta. Didalam mesyuarat ini dihadapan semua majikan. Beliau berkata mana-mana pemimpin Kesatuan yang berkepala batu akan dimasukkan dalam penjara. Dan pekerja-pekerja yang tidak mendengar arahan-arahan penyelia mereka hendaklah dibuang kerja dengan serta merta. Dan jika pemimpin lain yang mendesak untuk melaksanakan tindakan ini maka kesatuan akan disingkirkan dari pendaftaran nya.

Dengan arahan Yang Berhormat Menteri sendiri, pekerja semua telah disuruh balik bekerja dan mengeluarkan hasil yang biasa.

Seminggu kemudian, kesatuan kita telah menerima satu surat dari Pendaftar Kesatuan Sekerja dengan sekerasnya mencrangkan, jika pihak Exko tidak dapat memberi penjelasan dengan terang, didalam masa seminggu maka kesatuan kita akan disingkirkan dari pendaftarannya.

Akhirnya, majikan telah bersetuju untuk membayar elaun seperti berikut :-

1. Pekerja yang menerima bawah \$301/= mendapat elaun \$30/=
2. Pekerja yang menerima keatas \$301/= mendapat elaun \$25/=

Bayaran berkuatkuasa pada 1hb Oktober, 1973.

Perjanjian ini telah di tandatangani di Kementerian Buruh dan Tenaga Rakyat dengan di saksikan oleh Incik J.D. Kirunathan, Ketua Pengarah Hal Ehwal Perhubungan Perusahaan, Kementerian Buruh dan Tenaga Rakyat.

ORGANASASI

Sebaik baik sahaja kami mengambil peralihan pertadbiran dalam tahun 1975. Saudar Wong Teck Min menubuhkan Kesatuan di Kilang, United Motor Works.

16 orang pekerja di Syarikat ini telah menjadi mangsa kerana kegiatan aktiv beliau. Majikan telah mengetahui yang kesatuan kita akan di wujudkan di Kilangnya.

Pada hari kedua sedang ahli ahli kita berkumpul di luar kawasan ini, dengan tidak mena mena sekumpulan orang yang tidak di kenali merempoh kepada mereka. Dan mulai memukul ahli ahli kita. Dengan serta merta ahli ahli kita mulai bersurai dari tempat itu. Majikan UMW juga telah melapurkan perkara ini kepada polis.

Selepas kejadian ini, kami telah mendapat tahu yang pehak majikan telah mengujudkan kesatuan mereka sendiri. Setrusnya, kami menyadari pekerja pekerja di syarikat ini tidak lagi member kerjasama mereka kepada kami, Oleh sebab itu kami fikir tidak seharusnya kami menzuskan maksud ini lagi.

Walaupun kami telah gagal dalam percubaan ini, kami percaya pada satu hari nanti pekerja pekerja UMW sendiri akan memecahkan tabir besi yang di megah megahkan oleh majikan itu.

Bagi menyelesaikan perkara dengan secepat mungkin, kami percaya bahawa majikan UMW telah membayar saku hati kepada pekerja pekerja yang telah kena buang kerja mereka yang berkaitan sungguh gembira kerana tiap tiap seorang dari mereka menerima bayaran sughati yang lumayan.

## INTRODUCTION

My dear fellow-workers,

I would like to forward to you the brief account of our present Executive Council and also of our past achievements and losses during the year 1973/1974.

To balance between achievements and losses, I am proud to mention that we have made satisfactory progress in development and at the same time a little bit of losses in our struggle.

It took us a lot of guts and determinations, to face such threat like expulsion, suspension and warning served to us by Managements. Yet this is part of our struggle for survival. Such threat was purely received rapidly by our members in various plants.

It was not <sup>were</sup> easy to state that all these disputes <sup>we</sup> easily settled by us with Managements. We are lucky if these could be settled by not going to higher authorities, such as Industrial Court and Industrial Relation Officer under the care of the Ministry of Labour and Manpower. Coming back to this subject, minor cases could be easily settled on the spot, if by a sheer bit of luck and understanding of the Managements. Whereas major issues have to be put forward at the discretion of the higher authorities as mentioned above. But we all depend very much on the individual merit of each cases either we could win or lose.

When the present Executive Council took over the office Administration effectively on May, 1973 benefit members were then only 2,00 members. At a time I drafted this report for your food of thoughts, I was surprised to know that figure of membership of Our Union has jumped up to more than 4,00 members. When the memberships have gone up, naturally our grievances too would follow suits. Regret to mention here that sometimes it was not easy for us in the Executive Council in particular to get the co-operation in what whatever matters from our own members. For instance, when we have problem and the inquiry be taken into the Industrial Relation Office for settlement, we were surprised to learn that the majority of our members were reluctant to side the Union. Instead they would prefer to <sup>behave</sup> side the Managements. You may wonder why own members ~~behaving~~ like this. Simple answer to this question. The Managements might promised them with higher promotions as long as they are willing to work hand in hand with them. That actual ~~tricks~~ exercised by some Managements. This was part of the causes that striked between the fellowworkers mainly the misunderstanding.

Dear fellow-workers once again, I would like to sound !

we keep on fighting among ourselves I am very positive to say that we will fail in our struggle against the monopolism of the Managements who themselves are the tools of the capitalists. As such, I would like to stress clearly that the support for Union should come from the hearts of every members who is conscious that the Union is their protector. If this consciousness is in their minds that we could win at least at the will against our odd enemy that is the Management. We should not at all cost give ourselves at the mercy of these unorthodox Managements. So let it be a realism in future to our fellow-workers that Unity is strenght disunited we fall. Due to this is causes also an obstacles to us in the Executive Council to safeguard or to lift up the good image of the Transport Equipment and Allied Industries Employees Union.

Certainly, you all know that Our Executive Council is the Supreme Body in our Union which holds the power and directives. But it is regretted to sound that most of its members seems to fight among themselves. If this always happen, how could we in the Executive Council show good example to our ordinary workers. Perhaps to promote understanding too would be another problem. Yes why not? Therefore, my dear fellow-workers, I sincerely would like to extend to you my concrete advise - choose a leader whom you may have confidence in him to represent you all in another terms of office. Not only should be a candidate who really could tackle problems faces enough. He should be liberal in whatever he is undertakings. To be the Champion of the workers is not enough. Do choose your candidate wisely after it is for your own benefit. Our election would be here soon.

Before, I reach my last destination, I call upon you all my dearest fellow-workers to unite together under the Banner of Our beloved Union. There will be no different between the top people and general members. Let there be peace always between us. The long journey is yet to crossed by us all. Forward we march together, for the benefits of all our fellow-workers under the Banner of "Transport Equipment and Allied Industries Employees Union"

What is there the agreement between the greedy and the unfortunate and between the rich and the poor.

Indeed, it is wisely for you all to take note why Saudara Mun Chee Wah had been expelled from the post of Hon. Treasurer of our Union. Some of you might be confused and still not fully understand what caused his expulsion from the Executive Council. I would like to give you the reason why the Executive Council had taken such a drastic action against him. When he was in the post of Hon. Treasurer he was too greedy to put himself into other principal affairs in particular in running the administration of the Union. For instance like monopolizing the Union activities prior getting the approval of the Executive Council's permission.

Since, Saudara Mun Chee Wah's expulsion, the Executive Council had decided to appoint Saudara Wong Teck Min as Acting Treasurer. His appointment is approved by the Council and also by virtue of Our Union Constitution Rule (12) Clause (8) and the appointment took effect on 27th of March, 1974.

Now let us reflect back to the resignations of other Office Bearers. Saudara Shamsuddin bin Samian, Vice-President of the Union left his service from the General Motors (M) Sdn Bhd., Johore Bahru on December 15th, 1973, and Saudara Mohammed Hamid had been called by the Council to fill the vacant post. He warmly accepted the call made by the Council. As a matter of fact, during the last General Election, he stood for contest as Vice-President. He received a momentum number of votes that enabled him to be elected as the next vice-President.

Eventhough there were many resignations as you all can see yet the Council still had enough quorum to make a decision during the meeting. This saved the Council from not functioning well. As I draft this report, I am proud to say that there were 11 Council Meetings held in the past and followed by 10 Emergency Meetings. Also, during these periods, the Council had managed to arrange for a Joint meeting for Council Members and Works Committees. This is a part of achievement or progress that we all should be proud of.

MINUTES OF THE EXTRA ORDINARY GENERAL MEETING

This Meeting was held in the usual friendly atmosphere which was commenced at the Hall of Transport Union Workers, Jalan Barat, Petaling Jaya, Selangor on 2nd of December, 1973. The main agenda for the meeting was to approve the financial report for 1972/1973. But it was regretted greatly that Our External Auditor had delayed in the return of the reports after auditing. As such, we were unable to approve. Further to that, Our Constitution was too weak to be functioned by the Council. It was decided that some of these rules have got to be amended as soon as possible.

Not only for the reasons given above, but also it was disheartening to note the attendance on that day, was no too satisfactory. According to Our Union Constitution we must at least get 50% of the total members present if we want to amend any rules. In order to make this with a success, I call upon you all dear brothers and sisters to come in full force at the forthcoming General Election. So that we all can make some changes in our Constitution.

Coming back to this meeting, the financial report has been approved. Two scrutineers had been elected to replace the ones who had resigned. Both were from Cycle and Carriage Industries.

Saudara Balakrishnan P, was the Master of Ceremony on that day.

Saudara President and General Secretary welcomed the Members. As I said earlier, no amendments had been accorded due to the poor attendance. Since there was nothing more to be discussed, the meeting adjourned at 2.00 p.m. with a vote of thanks to the Chair.

His office took effect as from the 23rd of March, 1974.

Saudara A. Arumugam, the former General Secretary had to leave his post due to his promotion as Foreman in his working place - Associated Motor Industries (M) SDN BHD. He was one of the Principal Officers who completed and got the Collective Agreement signed between the MVAA and the Transport Equipment and Allied Industries Employees Union on 20th December, 1974. Because of his promotion as Foreman, he had been asked by the Council to step down from the Post of General Secretary. At the same time, our Union Constitution does not allow any member to hold two posts as soon as he was promoted to be the Managerial side. Due to his official resignation on 31st May, 1974 automatically Saudara Charles Mah Yong Hwee had to act as Acting General Secretary with effect from the same date.

The position of Saudara Charles Mah Yong Hwee as Acting General Secretary was in doubt. As a member of Hargill Engineering, he himself was included in the last expulsion of workers by the Management of Hargill Engineering (M) SDN BHD. The case had been forwarded to the Industrial Court to be judged. It is a matter of two months before we could decide as to whether he is still valid to hold the post that he is supposed to be holding. Indeed this is a very sad case.

If we reflect back on his position, we may be right to say that he is already invalid to hold any vital post in the TEU administration. Even the Registrar of Trade Unions had confirmed that he could not hold any higher post in the Union because he is no more considered as benefit member of the Union.

So due to no other alternatives, the President himself now got the power to choose any of the remaining Principal bearers to take charge of the Union Administration in accordance with Our Union Constitution under Article (12) Clause (8). As such, the President himself has decided to appoint Saudara Micheal Samy, who was considered as the most senior member of the Council to take charge of the administration and thus on behalf of the Acting General Secretary. His appointment took effect from the 6th of August, 1974.

Saudara Osman bin Mohd Noor, former Executive Council too had been promoted to Foreman by the Industries where he is being employed. Similar case as Saudara A. Arumugam, he has to submit his resignation from being the member of the Executive Council and the Union member. His resignation took effect as on the 31st of May, 1974.

Saudara Jamaluddin bin Mandak resigned from being a Council Member of the Union with effect from the 25th of November, 1973. At the same time he also resigned from his service at the Asia Automotive Industries (M) Sdn. BHD., He left for overseas in the late part of December, 1973. His vacant post in the Council was filled up by Saudara Micheal Foong Chin Bee which took effect as on the same date.

COLLECTIVE BARGAININGS

When the Second Executive Council was elected to take charge of the Administration in May, 1973. General Motors and Hargill Engineering were on hot negotiations. After the long negotiations they finally came to a settlement.

It was glad to note that this agreement was similar to that of the MVAA Agreement.

DISPUTES

I think that the year 1974, is the cloudiest year for Our Union. The reasons are given below.

On Friday the 18th of February, 1974, one of our Office Staff Saudara Omar bin Nordin was killed in a road mishap while carrying out his duties.

When he died, there was a dark future faced by his family with six mouths to support. The incident was a terrible blow to his family. We understood the difficulties that would be faced by his family. Immediately, we took action by collecting donations from our generous members in various plants. The total collections was about \$2,130.25.

This donation, was handed over to the late Saudara Omar Nordin's wife. The first donation was extended to her on Sunday the 13th of July, 1974, and the amount was \$300.00. Then the second donation was handed to her in the lawyer's office on the 23rd of July, 1974 and amount was one thousand seven hundred and thirteen dollars and cents twenty five only (1,713.25) Handing over ceremony was witnessed by Saudara Basri bin Hj. Ahmad, Saudara Wong Teck Min and Saudara Joseph Ambrose, Industrial Relations Officer of our Union.

The Executive Council conveyed their heartfelt thanks to all members in various plants for their generosity in extending their wonderful assistance.

In regard to his accident case, we in the Executive Council had taken every step to see that it received just judgement. The case would be heard in court soon.

HARGILL ENGINEERING (M) SDN BHD, SHAH ALAM

A sad incident happened in this plant where all our members had been sacked on the 31st of May, 1974. The mass dismissal was due to mass medical treatment by the members. This incident was brought to the attention of the Executive Council. And immediately they stepped in, trying to intervene and hoping to settle it. But luck was not with us.

When the Hargill Members started picketing outside the plant, the Headquarters had got to assist them with financial support. The Executive Council had decided to put out a large sum from our savings in order to help them to purchase daily necessities.

We requested the Ministry concerned to step in and try to solve this problem. At this joint meeting we met the Management. But there was no settlement.

Then again the meeting was arranged by the Ministry of Labour and Manpower. This time it was a success, 178 workers out of the 202 had been agreed upon by the Management to return to work. But the other 24 workers remained behind. The matter was being referred to the Industrial Court to judge what their fate would be for the future.

Since, there was no solution on this 24 workers, the Council had decided to take National action to support our workers in Hargill Engineering. But before we did so, we in advance, had been informed by the Ministry of Labour and Manpower and the Registrar of Trades Union that, we could not take such action, otherwise they will deregister our Union without further warning.

Even at the time I drafted this report, the matter was in the hands of the Industrial Court Authorities to decide the fate of the 24 of our fellow brother workers.

It is left to be seen what is the outcome of the hearing which would take place on the 24th, 25th and 26th September, 1974. God only knows.

To this sort of action taken individually by the members in Hergill Engineering, it also served as a lesson to us in other plants not to take the law in our own hands. Therefore, I sincerely request you my dearest fellow-workers to think twice before you take any action in your own accord. If you would like to take any actions in future, it is the best, for safety sake that you all must consult the Council. Do not get yourself drowned in the strong current. As you all know that the Labour Laws in this country are not in favour for workers but only for the Managements. Therefore, all of you should understand the real situation of our Union too.

CHAMPION MOTOR INDUSTRIES (M) SDN BHD., SHAH ALAM

Workers in Champion Motor Industries had taken Industrial Action for 6 days fighting for shift allowance and to reduce working hours. They won this battle. The Management bowed to their request. Due to their success in making demands, the agreement on this issue was signed on behalf of the Union were representatives who are Principal Officers, Saudara Basri b. Hj. Ahmad (President), Saudara A. Arumugam (General Secretary), Saudara Micheal Samy and Saudara Wong Teck Min (both Council Members) and Saudara Kassim Kechik (W/C/Secretary).

The signing took place in the Industrial Relations Office in Kuala Lumpur on the 10th of September, 1974.

#### SPECIAL RELIEF ALLOWANCE

Malaysian employees suffered alot due to the increased prices of daily necessities. While at this period the Management collected tons of money and sent them overseas.

In view of the critical situation, the Government decided to introduce a law demanding all employees to give special allowance to their workers.

Before the law was implemented, we had a meeting with the MVAA and it was agreed that the payment should be back dated ad from October, 1973. It was rejected by the Management so, we met them at the Ministry of Labour and Manpower several times.

The Union suggested to the Management the following categories of payments. Every worker should get 40% of their total wage per month, as suggested by the Union, but this was completely rejected by the Management.

Due to this, we met the Management again on several occasions at the Ministry of Labour and Manpower. When this came to be understood by the members in various plants, they themselves took the initiative to go slow in retaliation against the Management's attitude towards their COLA claims.

They did this without getting instruction from the Executive Council. Automatically the production dropped.

When realising this, the Management reported the matter to the Minister of Labour Tan Sri V. Manikavasagam. He called us for immediate meeting during which in front of all Management present, he said that any stubborn leader should be fixed behind bars and any employee refusing to listen to their supervisors at the working place should be expelled without prior warning. And if their leaders still insist to go ahead with the action, the Union would be deregistered.

At the direction of the Minister himself, the workers were asked to go back to normal production. Then only can the matter be discussed, and not negotiation. This was what had been told by the Minister himself.

A week after, we received a letter from the Registrar of Trades Union which firmly explained that if the Council failed to clear explanation within a week our Union will be deregistered.

Finally the Management compromised with us as given below:

- An employee earning below \$301.00 - received \$30/-
- An employee earning above \$301.00 - received \$25/-

As a special relief allowance with effect from the 1st of October, 1973 to the 31st of December, 1974.

The Agreement was signed between the Union and the MYAA in the presence of the Chief Industrial Officer, and Mr. J.D. Kirubanathan from the Ministry of Labour and Manpower.



ORGANISATION:

As soon as we took administration in 1973, saudara Wong Teck Min organised UMW workers to join our Union. The Executive Council was very happy because big fishes fell into our net. The Management came to understand that a Union would be formed in this Plant.

The Management victimised the 16 workers who were active in the Union. This was another headache to the Council



Then we called up all our members from various Plants to come to the UMW to show support to our brother workers in the UMW who would like to form a Union in their working place.

On the second day, while our members had gathered outside the UMW Plant, suddenly a group of people rushed out from the UMW gate and started walloping our members. Due to that incident our members dispersed immediately. The Management even reported the matter to the police.

After this incident, we came to understand that the UMW Management was forming its own Union. Then we came to realise that by this time, workers in the UMW plant were not giving us anymore co-operation. And we felt that it was useless for us to go ahead with the objective to form the Union.

Eventhough, we had failed in our attempt, we believe that one day the UMW workers themselves will break down the iron castle of the UMW's will.

To solve this problem in a quick way, the UMW Management had paid compensation to those workers who had been sacked from their services and thus the workers concerned were too happy to receive the money because each of them received quite a large sum.

Anyhow, this case is still pending in the Police hand.

RALEIGH CYCLE (M) SDN BHD

Union in this Company was organised by Saudara Mun Chee Wah. The Collective Agreement was discussed and finally agreed upon to have it signed on the 23rd of March, 1974. Representing the Union were Saudara Mun Chee Wah, Saudara Charles Mah Yong Hwee, Saudara Wong Teck Min and Saudara Abdul Hadi Salim.

Later the negotiation on Collective Agreement followed suit. The Union was represented by the following Executives and Works Committee Members:-

KAH MOTOR ASSEMBLY PLANT, BUTTERWORTH, PENANG

Union in this Plant was organised by Saudara A. Arumugam while attending a course organised by the MTUC in Penang. The Union was finally recognised by the Management on the 24th of August, 1973. After that we called for an Annual General Meeting for all members in that Plant to inform them as to how the Union should function.

Speaking about Bonus, the Management of this Company had made it clear that it is being paid to their workers annually, even though the Union was not functioning in the past years.

After the Union had been formed, we found that there were many issues which have to be settled. The Works Committee here then invited some Executive Members of the Union to assist them in solving these issues.

Therefore, to fulfill their request, the Union Headquarters then sent three of their principal Officers namely:- Saudara Micheal Samy, Saudara Micheal Foong Chin Bee, and Saudara Wong Teck Min. The meeting was held on the 19th of July, 1974 and by the will of God it was settled handsomely with satisfaction on both sides.

During the said meeting, both parties also discussed to arrange meetings for Collective Agreement which would be fixed at a later date.

Since the establishment Union in the Kah Motor in the North and South in Fiat and General Motors (M) Sdn Bhd. We now should be satisfied that at least our Union has separated far and wide in the states of Malaysia.

AGRICULTURAL TRACTORS SENDIRIAN BERHAD

One of the workers from the Company came and approached us and enquired as to whether the workers in the Plant can join our Union. We told them, we could help them to be registered under our Union banner. Then we wrote a letter for recognition to the Management of the Company, copy of the same letter to the Registrar of Trades Union and the Ministry of Labour and Manpower. We requested them to approve these workers to be members in our Union.

EDUCATION

Well, my dearest fellow-workers, you all might be aware that the Transport Equipment and Allied Industries Employees Union was formed in 1972. At that time none of our Principal Officers had got the opportunity to participate in any Seminars or Courses. Due to this cause, we were always kept in the dark and knew nothing what the Union was about. And this gave the Capitalists the chance to put pressure on us. And kept exploiting us endlessly. Therefore the Executive had decided to organise something for them in helping to be educated.

We received invitations from the IMF in July, 1973 and they invited us to send one of our representatives to the Seminar. We sent one of our Officers to attend the Seminar entitled, "Automotive Industries" which was held in Japan. The Executive Council had decided to send Saudara Mun Chee Wah in the hope that after attending this Seminar he would bring back some knowledge whatever he had gained and to teach our workers in our Union in particular, those who lacked education.

Then we received another invitation from MTUC to send representative to visit Russia. Our President Saudara Basti b. Hj Ahmad who had been selected by the Executive Council to make this trip. He left Malaysia on the 2nd of May, 1974 and returned to Malaysia on the 3rd of June, 1974 exactly one months trip. Even though we have done alot to polish up our Union but still I find there are not much improvements. As such, I request Saudara President to do something in order to educate our Union members in whatever possible ways in future.


